Amendment & Time extension

The following is amended in respect of NIT published vide: No. NH/CPS-1/P&C/W-1537/2025-26/281 Dated: 16/10/2025 for **“Restoration of Road at slide area on Power house- Surge shaft road near Baggi village, CPS-1.”**:

1. ITB Clause No. 22.2 is amended as below:-
