## 2.0 Eligibility Criteria for Bidders:

- 2.1 Bids of those Bidders who have not submitted the requisite Cost of bidding document and EMD (as per Instructions to Bidders (ITB Clause 3.0 & 4.0) shall not be considered for evaluation, except in case of exemption as per Clause No. Clause No. 4.1 of ITB.
- 2.2 The bidders must fulfil the following minimum Qualifying Criteria: -
- 2.2.1 The bid of such bidder, who already have any type of Live Letter of Award (LOA) / Work Order for the works/services (including Hiring of Vehicles) under PAF policy at Uri-II Power Station and Employees (Regular / Contractual ) upto the online bid submission end date, will not be considered.
- 2.2.2 This bid is reserved for PAF for which the bidder is to submit duly verified land oustee certificate.
- 2.2.3 PAFs, in the form of **Individuals** - having 100% beneficiaries from any of the below mentioned categories in relation to land acquired for Uri-II Power Station, NHPC Ltd. shall qualify:
- i. A family whose land or other immovable property has been acquired;
  - ii. The eligibility of PAF to participate in the tenders shall be considered taking into account the works awarded to PAF's family as a whole. The person, his family along with legal heirs shall be considered as single PAF. Declaration in this regard shall be provided by the PAF. In case of false declaration, the concerned PAF shall be debarred from participation of tenders for 6 months.
- 2.2.4 **One land oustee can apply for one vehicle of any category.**
- 2.2.5 No vehicle shall be engaged from land oustee applicant, if any of his family members has already been engaged as Contractor employee at Uri-II Power Station or any of his family member as NHPC regular employee or engaged in other regular benefit from NHPC.
- 2.2.6 The land oustee to whom LOA is being issued would also submit an undertaking that they will give preference to land oustee while engaging drivers for their vehicle.
- In support of the criteria under sl. no. (2.2.3) above, the bidder shall submit a certificate issued to him or his dependent/ legal heirs/ constituents of entity by the respective State Govt. Authority / District Authority/ Circle Officer/ Tehsildar/ any other Authority legally entitled to or entrusted by the State Government.**
- 2.2.7 The applications of those land oustees not having vehicles readily available for deployment at Power Station shall only be considered, if applicant submit an affidavit to provide the documents of the said vehicle with state permit/permission as applicable within two months from date of LOA and relevant documents of occupying new vehicles (bank documents, booking of vehicle etc.). If applicant failed to provide the vehicle with state permit/permission within prescribed time limit, his contract will be terminated and contract shall be awarded to next eligible bidder.
- 2.2.8 The applicants who have vehicle of requisite category/relevant model not older than 5 years shall only be considered for deployment with all relevant documents within seven days. However, applicant shall submit affidavit to provide state permit/permission as applicable within two months from date of LOA. If applicant failed to provide the vehicle with state permit/permission within prescribed time limit, his contract will be terminated.
- 2.2.9 The land oustees of Uri-II Power Station who are willing to provide vehicle shall have to furnish the following documents for qualifying in Selection Process: -

- a) Duly verified and valid documents in support of PAF of Uri-II Power Station.
- b) Self Signed Copy of Registration Certificate of Vehicle, Contract Carriage Permit, Road Tax, PAN, Aadhar, valid driving license, comprehensive Insurance of vehicle & Pollution certificate or the applicants who have not readily available vehicle may submit relevant documents of occupying new vehicles (bank documents, booking of vehicle etc.).
- c) ECS form duly filled and verified from concerned Bank along with a cancelled cheque

2.2.10 To qualify for award of the Contract for which bids are invited in the Notice Inviting Tender, the bidder must be **belonging to Project Affected Families (PAFs) of Uri-II Power Station.**

Eligibility Criteria shall be governed by “**Policy for reservation of works to be awarded on Local Competitive basis to PAFs of Uri-II Power Station**” as per NHPC Corporate Office **Circular No. CCW/2025/215 Dated 07.01.2025 as applicable from time to time.**

#### **A. Definitions of Project Affected Families (PAFs)**

The definition of Project affected families (PAFs) shall be as per definition provided in the “Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013” and subsequent amendments, if any.

The definition of Project affected families (PAFs) in relation to land acquired for NHPC is as below:

- i) A family whose land and other immovable property has been acquired.
- ii) A family which does not own any land but a member or members of such family may be agricultural labourers, tenants including any form of tenancy or holding of usufruct right, share-croppers or artisans or who may be working in the affected area for three years prior to the acquisition of the land, whose primary source of livelihood stand affected by the acquisition of land.
- iii) The scheduled tribes and other traditional forest dwellers who have lost any of their forest rights recognised under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 due to acquisition of land.
- iv) Family whose primary source of livelihood for three years prior to the acquisition of the land is dependent on forests or water bodies and includes gatherers of forest produce, hunters, fisher folk and boatmen and such livelihood is affected due to acquisition of land.
- v) A member of family who has been assigned land by the State Government or the Central Government under any of its scheme and such land is under acquisition.
- vi) A family residing on any land in the urban areas for preceding three years or more prior to the acquisition of the land or whose primary source of livelihood for three years prior to the acquisition of the land is affected by the acquisition of such land.

#### **B. Who are eligible**

- i) PAFs, in the form of Individuals, Partnership Firms, Group of People of Cooperative Societies / Self Help Groups (SHGs) / Companies (having 100% beneficiaries from the category of PAFs/Locals) ~~by locals from the notified area~~ will only be considered under the policy for award of the reserved works / services. **The eligibility of PAF to participate in the tenders shall be considered taking into account the works awarded to PAF’s family as whole. The person, his family alongwith legal heirs shall be considered as single PAF. Declaration in this regard shall be provided by the PAF. In case false declaration the concerned PAF shall be debarred from participation of tenders for Six months.**
- ii) The provisions regarding **Public Procurement (Preference to Make in India) Order-2017, restrictions under Rule 144(xi) of the General Financial Rules (GFRs)2017**, Micro and

Small Enterprises and Start-ups **as amended** from time to time shall be applicable for this policy.

2.2.11 All Start-ups (whether MSEs or otherwise), falling within the definition as per Gazette notification- G.S.R. 501(E) dt. 23.05.2017 or as amended from time to time are exempted from meeting the qualification criteria in respect of Prior Experience-Prior Turnover subject to their meeting the quality and technical specifications for which necessary documents shall be submitted by such bidders. However, the Employer reserves the right to deny such exemptions to Start-ups (whether MSEs or otherwise) in case of circumstances like procurement of items related to public safety, health, critical security operations and equipment's etc. Declaration in this regard is to be submitted by the Bidder as per Annexure-VIII.

2.2.12 All Micro and Small Enterprises (MSEs) are exempted from meeting the qualification criteria in respect of Prior Experience-Prior Turnover in public procurement subject to meeting of quality and technical specifications for which necessary documents shall be submitted by such bidders.

**NOTE: Only those Micro & Small Enterprises (MSEs)/ Startups will be given benefit, which has valid certificate for the services covered under this tender.**

2.2.13 The reference date for considering the period for eligibility / qualification requirements above shall be the last day of the month previous to the one in which tenders are invited.

2.2.14 Each bidder must also produce with their bid- PAN, Goods & Service Tax Identification No (GSTIN) (Optional as RCM is applicable for GST).

2.3 The Bidder should not have been banned / de-listed / black listed / debarred from business or declared ineligible on the grounds mentioned in Para 6 of Guidelines on Banning of Business Dealings (Annexure-A) to Integrity Pact *[if applicable]*, ITB Clause 9.0. Self-declaration in this regard is to be submitted as per enclosed Annexure-III.

2.4 To improve transparency and fairness in tendering process and/or during execution of work undertaken, the Employer is implementing Integrity Pact as per Clause No. 9.0 of the ITB. The bidder must submit the Integrity Pact as per Proforma (Annexure-II) duly signed *[if applicable]* as per Clause 9.0 of ITB.

Pre-contract Integrity Pact *[if applicable]* is to be executed on plain paper with NHPC Ltd. at the time of submission of Bids. The successful bidder (Contractor) shall submit duly executed Integrity Pact on Non-Judicial Stamp Paper of appropriate value prior to signing of Contract Agreement.

To oversee the compliance under the Integrity Pact, **Sh. Prabhash Singh, Sh. Upendra Malik** and **Dr. Vinod Aggrawal** have been appointed as an Independent External Monitors (IEM) by the owner. The Contact Address of IEM is as under: -

2.6 Bids of only those Bidders who are meeting the Eligibility Criteria specified above will be considered for evaluation and award of the Contract. Bidders will submit duly attested /

notarized requisite documents and testimonials with their bids to prove their credentials and claim of meeting the Eligibility Criteria.
