2.0 Eligibility Criteria for Bidders:

2.1 Bids of those Bidders who have not submitted the requisite Cost of bidding document and EMD (as per ITB Clause 9.0) shall not be considered for evaluation, except in case of exemption as per Clause No. 9.1 of ITB.

2.2 The bidders must fulfil the following minimum Qualifying Criteria:

2.2.1 Technical Criteria:

i) The Bidder should be manufacturer of #Hydraulic turbines / PaT (Pump As Turbine) and should have successful experience in “Design, Manufacturer, Supply and Commissioning of Hydraulic turbines / PaT (Pump As Turbine) system of unit capacity of 40kW (or above) at one (1) commercial installations or 20KW (or above) at two (2) commercial installations during previous 15 (fifteen) years.

OR

ii) If the bidder is not manufacturer of #Hydraulic turbines / PaT (Pump As Turbine), bidder should have successful experience in “Supply, Installation, Testing and Commissioning of Hydraulic turbines / PaT (Pump As Turbine) system of unit capacity of 40kW (or above) at one (1) commercial installations or 20KW (or above) at two (2) commercial installations during previous 15 (fifteen) years and in such case, bidder shall associate manufacturer of #Hydraulic Turbines / PaT (Pump As Turbine) of minimum 40KW capacity, provided bidder shall submit the credential of proposed manufacturer and proposed manufacturer shall submit authorization as per Annexure-XVIII of ITB.

- iv) In case a bidder is participating in tender on behalf of one manufacturer, he is not allowed to participate/ quote on behalf of another manufacturer in this tender or in a parallel for the same item. All such bids will be rejected.
- v) The equipment supplied should have performed satisfactorily for one year from the date of commissioning.

2.2.2 Financial Criteria:

a. Turnover:

The bidder should have Minimum average annual turnover of **INR 454.63 Lakh** for the immediately preceding two (02) consecutive financial years.

b. Working capital:

The working capital (current assets minus current liabilities) shall be at least 2 (two) times the monthly cash flow requirement. The minimum working capital shall not be less than **INR 71.53 Lakh**.

For this purpose, current assets and current liabilities will be considered as classified in the audited balance sheet/ equivalent financial statements including profit and loss statement of the immediately preceding financial year. If audited financial statement of the immediately preceding financial year is not available, then the bidder shall submit these statements certified by a Chartered Accountant.

c. Net worth:

The bidder should have positive “Net Worth” in at least 02 (two) Financial years out of the last 03(three) financial years, with the condition of Positive Net Worth in immediately preceding financial year.

‘Net Worth’ means the aggregate value of the paid-up share capital and all reserves created out of the profits, securities premium account and debit or credit balance of profit and loss account, after deducting the aggregate value of the accumulated losses, deferred expenditure and miscellaneous expenditure not written off, as per the audited balance sheet, but does not include reserves created out of revaluation of assets, write-back of depreciation and amalgamation.

For assessment, relevant pages of Annual Report containing Net worth figure duly certified by Authorized representative of bidders, otherwise, figure duly authenticated by the statutory Auditors should be submitted.

Note:

- (i) The experience of supervision of erection/installation, testing & commissioning shall also be considered at par with own experience of erection, testing & commissioning.

(ii) In case Purchaser/Owner issuing experience certificate is non-government entity, the bidder shall also submit notarized copy of TDS certificate for corresponding value of Supply Orders/Work Orders issued by the Purchaser/Owner.

In support of criteria 1.1, the bidder shall submit copies of supply orders along with Installation/completion report and performance certificate for satisfactory operation issued by client for minimum one year from the date of commissioning.

- Other income shall not be considered for arriving at the Annual Turnover.
- The Bidder's financial evaluation vis a vis the requirement as stipulated above shall be done on the basis of duly printed (offset) Annual Report/Equivalent financial statement for the immediately preceding 03 (three) years submitted by the Bidder along with the Bid. In case, bid submission date falls up to 30th September, the annual reports/ Equivalent financial statement up to previous year of the immediate preceding Financial Year shall be considered and for the Tenders having bid Submission date after September, the annual reports/ Equivalent financial statement up to immediate preceding Financial Year shall be considered. Further, standalone audited Annual Financial Statement of Bidder shall be forming part of the Annual Report/ Equivalent financial statement.

In case, if the Bidder has not submitted the above Annual Report/ Equivalent financial statement along with the Bid, then a certificate from CEO/ CFO of the Bidder shall be submitted along with Bid mentioning that the requirement of Annual Report as per governing law of country is not mandatory in case of such bidders Equivalent financial statement shall be considered. In such cases duly notarized copies of Audited Printed Annual Financial Statement (Balance Sheet, Profit & Loss Statement, cash flow statement, Auditor's Report thereon including all relevant Schedules/ annexure etc.) for the immediately preceding 3 (three) years be submitted by the Bidder along with the Bid. The Annual Financial Statement shall be considered for evaluation

in same manner as defined in above Para for consideration of Annual Reports/ Equivalent financial statement.

- e) The qualification given by statutory Auditors on the Financial Statements which have impact on Net Worth, Turnover, Working Capital or any other financial item shall be taken into account for calculating the above financial parameters of Qualifying Criteria.
- f) For conversion to US\$ the exchange rate at the end of the respective accounting year shall be considered.

For this purpose, current assets and current liabilities will be considered as classified in the audited balance sheet/ equivalent financial statements including profit and loss statement of the immediately preceding financial year. If audited financial statement of the immediately preceding financial year is not available, then the bidder shall submit these statements certified by a Chartered Accountant.

c. Net worth:

The bidder should have positive “Net Worth” in at least 02 (two) Financial years out of the last 03(three) financial years, with the condition of Positive Net Worth in immediately preceding financial year.

‘Net Worth’ means the aggregate value of the paid-up share capital and all reserves created out of the profits, securities premium account and debit or credit balance of profit and loss account, after deducting the aggregate value of the accumulated losses, deferred expenditure and miscellaneous expenditure not written off, as per the audited balance sheet, but does not include reserves created out of revaluation of assets, write-back of depreciation and amalgamation.

For assessment, relevant pages of Annual Report containing Net worth figure duly certified by Authorized representative of bidders, otherwise, figure duly authenticated by the statutory Auditors should be submitted.

Note:

- (i) The experience of supervision of erection/installation, testing & commissioning shall also be considered at par with own experience of erection, testing & commissioning.

(ii) In case Purchaser/Owner issuing experience certificate is non-government entity, the bidder shall also submit notarized copy of TDS certificate for corresponding value of Supply Orders/Work Orders issued by the Purchaser/Owner.

In support of criteria 1.1, the bidder shall submit copies of supply orders along with Installation/completion report and performance certificate for satisfactory operation issued by client for minimum one year from the date of commissioning.

(iii) In support of criteria 1.2, the bidder shall submit copies of supply orders along with Installation/completion report and performance certificate for satisfactory operation issued by client for minimum one year from the date of commissioning and shall also submit proposed manufacturer's credentials such as supply order and documentary evidences of successful dispatch/delivery during previous fifteen years.

(iv)

- Other income shall not be considered for arriving at the Annual Turnover.
- The Bidder's financial evaluation vis a vis the requirement as stipulated above shall be done on the basis of duly printed (offset) Annual Report/Equivalent financial statement for the immediately preceding 03 (three) years submitted by the Bidder along with the Bid. In case, bid submission date falls up to 30th September, the annual reports/ Equivalent financial statement up to previous year of the immediate preceding Financial Year shall be considered and for the Tenders having bid Submission date after September, the annual reports/ Equivalent financial statement up to immediate preceding Financial Year shall be considered. Further, standalone audited Annual Financial Statement of Bidder shall be forming part of the Annual Report/ Equivalent financial statement.

In case, if the Bidder has not submitted the above Annual Report/ Equivalent financial statement along with the Bid, then a certificate from CEO/ CFO of the Bidder shall be submitted along with Bid mentioning that the requirement of Annual Report as per governing law of country is not mandatory in case of such bidders Equivalent financial statement shall be considered. In such cases duly notarized copies of Audited Printed Annual Financial Statement (Balance Sheet, Profit & Loss Statement, cash flow statement, Auditor's Report thereon including all relevant Schedules/ annexure etc.) for the immediately preceding 3 (three) years be submitted by the Bidder along with the Bid. The Annual Financial Statement shall be considered for evaluation

in same manner as defined in above Para for consideration of Annual Reports/ Equivalent financial statement.

- c) In case where Audited financial results for the immediately preceding year are not available, then a statement of account as on the closing date of the immediately preceding financial year depicting the Turnover and Net Worth (calculated as per laid down criteria) duly certified by their Statutory Auditor/ Certified Public Accountant carrying out the statutory audit shall be enclosed with the Bid along with copy of appointment letter of the statutory auditor. The certificate should be issued with Unique Documents Identification Number (UDIN) as per Gazette Notification No.1-CA(7)/192/2019 dated 02.08.2019 or any other document Identification number issued to Certified public Accountants by their respective Institute, if applicable.
- d) Wherever, the Annual Report/ duly notarized copies of Audited Printed Annual Financial Statement are in language other than English, then copy duly translated & printed in English language and certified by approved/ recognized English translator shall be submitted with the Bid.
- e) The qualification given by statutory Auditors on the Financial Statements which have impact on Net Worth, Turnover, Working Capital or any other financial item shall be taken into account for calculating the above financial parameters of Qualifying Criteria.
- f) For conversion to US\$ the exchange rate at the end of the respective accounting year shall be considered.
- g) For working out the turnover and working capital criteria, the bidder's figures which could be in any currency, the respective year figures of turnover & working capital from the Annual Statement shall be converted to US\$ equivalent by adopting the exchange rate(s) prevailing on the last date of the respective accounting year(s)
- h) For the purpose of compliance to the stipulated turnover criteria given at Financial Criteria, the relevant turnover from Joint Venture(s) as declared in the Joint Venture Agreement shall also also be considered.

vi) The reference date for considering the period for eligibility/qualification requirement above shall be the last day of the month previous to the one in which tenders are invited.

vii) **As the work is being highly specialized in nature, therefore No relaxation in Qualification Requirements shall be given to Micro & Small Enterprises (MSEs) and Start-up firms.**

2.3 The Bidder should not have been banned/ de-listed/ black listed/ debarred from business or declared ineligible on the grounds mentioned in para 6 of Guidelines on Banning of Business Dealings (Annexure-II). Self-declaration in this regard is to be submitted by the Bidder as per Annexure-VII.

2.4 To improve transparency and fairness in tendering process and/or during execution of work undertaken, the Employer is implementing Integrity Pact as per Clause No. 17.0 of this ITB. The bidder must submit the Integrity Pact as per Proforma (Annexure-II of Section-0) duly signed as per Clause 17.0 of ITB.

2.5 The Bidder, against whom proceedings for insolvency under the Insolvency and Bankruptcy code 2016, or as amended from time to time, have started, shall not be eligible for bidding. Self-declaration in this regard is to be submitted as per enclosed Proforma (Annexure-XI)
