Allocation of Works in Case of Non-Receipt of Bids for Any State</p> <p>16.1 Bids are invited for various States / UT's under this Tender.</p> <p>16.2 In the event that no bid is received for any particular State (hereinafter referred to as “Non-responsive State”), NHPC REL reserves the right to undertake the solarization of buildings located in such Non-responsive State through any Bidder who has been declared successful for any other State under this Tender.</p> <p>16.3 Subject to the consent of the successful Bidder referred to in Clause 16.2 above, the buildings of the Non-responsive State shall be offered to such Bidder at the same tariff as quoted by the Bidder for the State for which it has been declared successful.</p> <p>16.4 It is clarified that: (a) Buildings located in Normal States shall be offered only to successful Bidders of Normal States. (b) Buildings located in Special States shall be offered only to successful Bidders of Special states.</p> <p>16.5 The order of offer under Clause 16.2 shall be as follows: (a) In case of a Normal State, the buildings shall first be offered to the successful Bidder who has quoted the lowest tariff among all successful Bidders for Normal States. (b) In case of a Special State, the buildings shall first be offered to the successful Bidder who has quoted the lowest tariff among all successful Bidders for Special States.</p>

			<p>16.6 In the event the first eligible Bidder declines the offer, NHPC REL shall have the right to offer the same to the next lowest successful Bidder in the respective category (Normal or Special State), and so on, at the applicable quoted tariff, until the allocation is finalized.</p> <p>16.7 The decision of NHPC REL in this regard shall be final and binding on all Bidders, and no claim or dispute shall be entertained on this account.</p>
