Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to

increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

Authorized dealer of a manufacturer of the equipment/system to quote on behalf of their manufacturer in case manufacturer does not quote directly. In such a case, the authorized dealer shall have to submit a tender specific dealership or authorization certificate issued by manufacturer and having validity of such authorization for considerable duration shall be eligible for the particular tender.

(iii) A valid ISO certification of manufacture for manufacturing the specified equipment's/system should be submitted with the bid.

(iv) In case a dealer is participating in a tender on behalf of one manufacturer, he is not allowed to participate/quote on behalf of another manufacturer in this tender or in a parallel for the same item. All such bids with same make/manufacturer will be rejected.

(v) The Bidder should have supplied at least two similar equipment/ systems of same capacity or higher in previous seven years.

(vii) The equipment/system supplied should have performed satisfactorily for one year from the date of commissioning. The bidder should furnish the performance report from the clients.
