If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

**WORK RESERVED FOR PROJECT AFFECTED FAMILIES OF SEWA-II POWER STATION AND/OR LOCAL RESIDENTS OF KATHUA DISTRICT OF J&K**

**(Bid of PAF/Local bidders shall be technically evaluated and bid of other non-PAF/non-Local bidders shall be summarily rejected in technical evaluation.)**

This work is reserved for PAFs and locals residing near to the Power Station. Definition of Project Affected Family (PAFs) shall be as per the definition provided in the "Right to fair compensation and transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and subsequent amendment, if any. The detailed definition in respect of PAFs and Locals for NHPC is specified in Annexure-A.

**Eligibility criteria for this work/ service for Project Affected Family (PAFs) and locals shall be as under:**

- (i) PAFs, Individuals, partnership firms, group of people in the form of Cooperative Societies/ Self Help Groups (SHGs) by locals from the notified areas will only be considered.
- (ii) The provisions regarding Micro and Small Enterprises and Start-ups shall be applicable.
- (iii) For benefit of larger population of nearby area of Power Station, at a time not more than 04 works/services to be allotted/awarded to the same entity. Financial limit of award to any single entity at any point of time for works and services shall be limited to Rs. 125 lakhs. The reference date for considering the eligibility for bidders as PAF/Locals shall be the last date of the submission of the online bid.
- (iv) In the event of non-participation of PAFs/ Locals in the 'Local Competitive Bidding' process for the listed works, then HOP shall record circumstances/ reasons for such non-participation and may initiate the process afresh to award such works on Open Tender Basis.
- (v) **Bidder should submit documental proof for PAFs and /or Locals as following 02 documents:**
  - a) **Domicile Certificate of Kathua District of J&K and**
  - b) **Ration Card / Voter ID Card.**
- (vi) **Bidder should submit details of awarded active work with duration of period dealt with Sewa-II PS under work reserved for PAFs and/or Locals.**

**Definition of Project Affected Families (PAFs) and Locals**

**A. Definition of Project Affected Families (PAFs)**

- (i) a family whose land or other immovable property has been acquired;
- (ii) a family which does not own any land but a member or members of such family may be agricultural labourers, tenants including any form of tenancy or holding of usufruct right, share-croppers or artisans or who may be working in the affected area for three years prior to the acquisition of land, whose primary source of livelihood stand affected by acquisition of land;
- (iii) the Scheduled Tribes and other traditional forest dwellers who have lost any of their forest rights recognized under the scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act 2006 due to acquisition of land;
- (iv) family whose primary source of livelihood for three years prior to the acquisition of land is dependent on forests or water bodies and includes gatherers of forest produce, hunters, fisher folk and boatmen and such livelihood is affected due to acquisition of land;
- (v) a member of the family who has been assigned land by the State Government or the Central Government under any of its schemes and such land is under acquisition;
- (vi) A family residing on any land in the urban areas for preceding three years or more prior to the acquisition of land is affected by the acquisition of such land.

**B. Definition of Locals**

**The geographical limits for defining the local residents eligible under the policy at the individual Project/Power Station shall be district(s) where the Projects and its components are located. In case of Sewa-II PS, local residents shall be from District - Kathua (J&K).**

**C. Eligibility:**

i. PAFs in the form of Individuals, partnership firms, group of people in the form of Cooperative societies/ Self Help Groups (SHGs)/ Companies (having 100% beneficiaries from the category of PAFs/Locals) by locals from the notified area will only be considered under the policy for award of the reserved works/services. **The eligibility of PAF to participate in the tenders shall be considered taking into account the works awarded to PAF's family as a whole. The person, his family along with legal heirs shall be considered as single PAF. Declaration in this regard shall be provided by the PAF.** In case of false declaration the concerned PAF shall be debarred from participation of tenders for six months.
