1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

6.0 Delivery/Completion Period:

- 6.1 Supply/ delivery of complete material including Installation, Testing & Commissioning shall be completed in 06 months from the date of Award (06 months for delivery of material including time period for approval of drawing and 02 months for installation, testing, commissioning, acceptance testing).
 - 6.2 The supplier shall submit the all the detailed drawing to NHPC for approval/technical clearance by competent authority prior to manufacturing process within 3 weeks.
 - 6.3 Drawings submitted by supplier shall be checked and the reply regarding approval, objections, modifications, queries etc. shall be conveyed within 02 weeks' time. The supplier shall resubmit the drawings by clarifying objections, queries, modifications within 01-week time and same shall be checked within further 01-week time. Delay on account of approval of drawing shall be in scope of contractor.
 - 6.4 In case of delay in delivery / completion of work, the LD shall be applicable for the delay from the end date of total completion period to actual completion/acceptance date.
 - 6.5 Delay due to non-availability of site owing to non-availability of shutdown/ site readiness or any other reason non accountable to contractor shall be excluded from the completion period.
 - 7.0 Liquidated Damages: If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period, until actual delivery or performance, as pre-estimated damages not exceeding 5% of the total contract value without any controversy/dispute of any sort whatsoever. However, in case of inordinate delay maximum deduction shall be 10% of the total contract value.
- Note: Inexcusable delays of more than one-fourth (25%) of the completion period specified in the contract shall be treated as inordinate delay(s).

8.0 Agreement

- 8.1 After issue of the Letter of Intent / Award, the Purchaser shall prepare the Agreement on the stamp paper on the Form enclosed as Annexure C for Supply & Erection contracts and the parties shall sign the said Agreement within 30 Days from the date of issue of Letter of Intent / Award. The expenses of completing and stamping the agreement shall be borne by the Contractor. The Contractor shall furnish 3 sets of such Contract agreements to the Purchaser. After the Agreement, one original set shall be handed over to the Contractor and the remaining two sets shall be retained by the Purchaser.
- 8.2 After the bid has been accepted by the Purchaser, all orders or instructions to the Contractor shall, except as herein otherwise provided, be given by the Engineer-in-Charge or his authorised representative, in writing, on behalf of the Purchaser.

9.0 Integrity Pact

To improve transparency and fairness in tendering process the Purchaser/ Employer is to implement a transparency pact. The Pre-Contract integrity pact, signed by all the bidder and the Purchaser/ Employer shall commit the persons/officials of both the parties,

The equipment/ items shall be warranted against poor quality or workmanship of material or manufacturing defects for a minimum period of 24 months commencing upon the setting to work of item/ plant or 30 months from the date of despatch whichever is earlier. During the Warrantee period the Supplier shall repair/replace the defected items free of cost and no conveyance or any other charges shall be paid. If any defect is not remedied within a reasonable time, the Purchaser may proceed to do the work at the Supplier's risk and expense, but without prejudice to other rights, which the Purchaser may have against the Supplier in respect of such defects.

11.0 Transit Insurance:

Transit Insurance shall be borne by the Supplier .

Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.

4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
