Online electronic bids (e-tenders) under two cover system are invited on behalf of Parbati H.E. Project (Stage-II), NHPC Limited (A Public Sector Enterprise of the Government of India) from domestic bidders registered in India on Open Tender basis for "Checking, Testing and Refilling of Carbon Dioxide (CO2) Cylinders fitted in the Carbon Dioxide (CO2) Fire Protection System for 4 nos. of Unit Generators (220 MVA) in Power House of Parbati HE Project, Stage-II (Package No. C-718)".

2.0 Eligibility Criteria for Bidders:

- 2.1 Bids of those Bidders who have not submitted the requisite Cost of bidding document and EMD (as per Instructions to Bidders (ITB) Clause 3.0 & 4.0) shall not be considered for evaluation, except in case of exemption as per Clause No. 3.2 & Clause No. 4.1 of ITB. The bidder claiming the exemption as above is required to submit the supporting document i.e. valid Udyam Registration Certificate as per ITB Cl. No. 3.2 & 4.1 of Tender Documents.
- 2.2 The bidders must fulfil the following minimum Qualifying Criteria:
- 2.2.1
- (a) The Bidder shall be Manufacturer of the **Carbon Dioxide (CO2) Gas** and submit the documents in support of the same.

or

The Bidder shall be Authorized dealer/distributor of the Manufacturer of the **Carbon Dioxide (CO2) Gas.**

In case of authorized dealer, bidder shall have to submit notarized copy of "General Authorized Dealership Certificate" issued by the manufacturer.

Only agencies submitting a general Dealership or Authorization certificate issued by the Manufacturers, without reference to any specific tender and having validity of such authorization for the considerable duration shall only be considered for determining the eligibility of the Bidder for the

particular tender. Authorization issued with reference to the specific tender in favour of particular dealer/bidder will not be entertained.

- (b) The bidders should have successfully executed/ completed contract as mentioned below for the similar work i.e. Refilling of CO₂ Cylinders during last five years ending last day of month previous to the one in which tenders are invited:
 - (i) One Contract/ Supply Order of at least Rs. 8.19 Lakhs Or
 - (ii) Two Contract(s) / Supply Order(s) each costing at least Rs. 5.12 Lakhs Or
 - (iii) Three Contract(s) / Supply Order(s) each costing at least Rs. 4.09 Lakhs.

The bidder shall provide with their Techno-Commercial Bid, <u>notarized copy</u> of Letter of Award/Supply Order, Bill of Quantities and execution/ completion certificate issued by the purchaser/ owner against above contract. In case of experience certificates produced by the contractors for having executed works for Private Organizations, TDS Certificates shall also be produced along with experience certificate.

Similar work referred above shall means "Refilling of CO2 Cylinders".

- (c) Average Annual Turnover during last 3 years, ending 31st March 2022 should not be less than Rs. 3.07 Lakhs. The bidder shall submit duly notarized copy of Auditor's reports/audited Balance sheet & Profit Loss account for the last three financial years or Certificate from Chartered Accountant in respect of Annual Turnover during last 3 years, ending 31st March 2022 along with copy of ITR to prove financial standing of the bidder.
- (d) The testing of cylinders should be carried out through the agency who are authorized from PESO (Petroleum and Explosive Safety Organization) for testing of CO2 cylinders. Supporting document in this regard to be submitted with bid.

- 2.2.4 The reference date for considering the period for eligibility / qualification requirements above shall be the last day of the month previous to the one in which tenders are invited.
- 2.2.5 Bidder shall be Class-I Local Supplier as defined in Public Procurement (Preference to Make in India) order for Goods/ Services/ Works issued by Department of Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry Order No. P-45021/2/2017-PP (BE-II) dated 16th Sept, 2020. In this regard bidder shall be required to submit undertaking w.r.t. Local content/ Class-I/ Class-II local supplier etc. as per Annexure-X along with the bid. They shall also give details of the location(s) at which the local value addition is made.
- 2.2.6 The bidder should submit copy of PAN Card and Goods & Services Tax Identification No. (GSTIN).
- 2.2.7 The bidder should submit copies of original documents defining the constitution or legal status, place of registration and principal place of business and notarized copy of power of attorney of the signatory of the Bid to commit the Bidder.
- 2.3 The Bidder should not have been banned/ de-listed/ black listed/ debarred from business or declared ineligible on the grounds mentioned in ITB Cl. No. 12.0(d) or para 6 of Guidelines on Banning of Business Dealings (Annexure-A) to Integrity Pact, ITB Clause 8.0. Self-declaration in this regard is to be submitted as per enclosed Annexure-III.

- 2.5 Bids of only those Bidders who are meeting the Eligibility Criteria specified above will be considered for evaluation and award of the contract. Bidders will submit duly notarized requisite supporting documents and testimonials with their Bids to prove their credentials and claim of meeting the Eligibility Criteria.

- 3.0 In the event of the specified date for the submission of offline documents being declared a holiday for the Employer, the hard copies of the documents will be received up to the specified time on the next working day. However, the date and time for online submission of the bids shall continue to be the date and time specified above or any amendment for the same.
- 4.0 Online submission of the Bids (incl. attachments) will not be permitted on the portal after expiry of submission time and the Bidders shall not be permitted to submit the same by any other mode. In such case, even if the bidder has submitted the specific documents in hard copy (ies) in original within the stipulated deadline, its bid shall be considered as late and shall not be considered at all any further. Offline documents, if received by the Employer after the deadline for submission of hard copies, then it will be considered as late bid even if the bidder has uploaded the bid online within the deadline. In such a case, the bid uploaded on the portal shall not be considered at all any further.
- 5.0 At any time prior to the deadline for submission of bid, the Employer may amend the Tender Document by issuing corrigendum/addenda/amendment which shall be notified on portal http://eprocure.gov.in/eprocure/app WHPC website www.nhpcindia.com. Therefore, the bidders are advised to visit the site regularly before deadline for submission of bids. Bidder is required to acknowledge the receipt of any such amendment from the CPP Portal. It will be presumed that the amendment has been accepted and the information contained therein has been taken into account by the Bidder in its bid. The bidders are requested to see the web site once again before the due date of tender submission/ opening to ensure that they have not missed any corrigendum/ addendum uploaded against the said tender after downloading the tender document.

The responsibility of downloading the related corrigendum/ addendum, if any, will be that of the downloading firm/prospective bidder.

- 6.0 Bids will be opened as per the schedule at the aforesaid venue. In case the office of Employer happens to be closed or in-advertent condition of non-availability/ non-working of Central Public Procurement (CPP) portal or for any other reason on the date of opening of bid as specified, the bid will be opened on the next working day at the same time and venue.
- 7.0 Tenderer who has downloaded the tender from the NHPC website www.<u>nhpcindia.com</u> or Central Public Procurement Portal (CPPP) website <u>http://eprocure.gov.in/eprocure/app</u>, shall not tamper/modify the tender document including downloaded price bid template in any manner. In case if the same is found to be tempered/ modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with NHPC.
- 8.0 The details/ information regarding online tendering i.e. Registration on CPP portal, Preparation of Bid and Submission of bid are available in the tender document and as well as on CPP Portal under "Bidders Manual Kit".
- 9.0 NHPC reserves the right to reject any or all tenders and shall not be bound to assign any reason for such rejection.
