## 2.0 Eligibility Criteria for Bidders:

2.1 Bids of those Bidders who have not submitted the requisite ~~Cost of bidding document and~~ EMD (as per Instructions to Bidders (ITB) Clause 3.0 and 4.0) shall not be considered for evaluation, except in case of exemption as per ~~Clause No. 3.2 & Clause No. 4.1~~ of ITB.

Further, those Bidders who fail to declare Udyog Aadhar Memorandum (UAM) number on GeM Portal shall not be able to avail the benefits available to MSEs as contained in Public Procurement Policy for MSEs Order, 2012 issued by Ministry of Micro, Small & Medium Enterprises for tenders invited electronically through GeM Portal. Such bidders shall be treated as non-MSE bidders and bids of such

Bidders shall be considered only if it is accompanied by ~~Cost of bidding document (Tender Fee)~~/ EMD.

2.2 The bidders must fulfil the following minimum Qualifying Criteria:-

2.2.1 (A) The bidder should have successfully executed contract during last seven years ending last day of month previous to the one in which applications are invited for the similar work as given below:

One similar work done / performed work costing not less than the amount equal to 80% of the Estimated Cost.

OR

Two similar work done / performed works costing not less than the amount equal to 50% of the Estimated Cost.

OR

Three similar work done / performed works costing not less than the amount equal to 40% of the Estimated Cost.

The similar works above shall mean **“diving assistance work of Hydro Mechanical gates/stoplog grooves/trash rack/ De-silting Basin/HRT etc. Installed at Dam/Power House/Barrage/ Irrigation plant etc.”**

**Note: The qualification criteria shall be considered work done for a minimum period of one year irrespective of length of contract subject to satisfactory performance certificate issued by the employer for the particular work done.**

**In case of client (issuing experience certificate) being non-government entity, the Contractor shall enclose TDS Certificate for the work for which experience has been claimed by the Contractor.**

(B) Average Annual Turnover during last 3 years, ending 31st March 2022 should not be less than the 30% of the estimated cost. The bidder shall submit Certificate from Chartered Accountant in respect of Annual Turnover during last 3 years, ending 31st March 2022 along with ITR to prove financial standing of the bidder. FRN of CA must be quoted on the certificates issued by CA.
