2.0 Eligibility Criteria for Bidders:

2.1 Bids of those Bidders who have not submitted the requisite Cost of bidding document and EMD (as per Instructions to Bidders (ITB) Clause 3.0 & 4.0) shall not be considered for evaluation, except in case of exemption as per Clause No. 3.2 & Clause No. 4.1 of ITB.

Further, those Bidders who fail to declare Udyog Aadhaar memorandum (UAM) number on CPP Portal shall not be able to avail the benefits available to MSEs as contained in Public Procurement Policy for MSEs Order, 2012 issued by Ministry of Micro, Small & Medium Enterprises for tenders invited electronically through CPP Portal. Such bidders shall be treated as non-MSE bidders and bids of such Bidders shall be considered only if it is accompanied by Cost of bidding document (Tender Fee) / EMD.

Those Bidders submitting Udyam Registration certificate doesn't need to declare Udyog Aadhaar memorandum (UAM) number on CPP Portal.

Above declaration on CPP Portal can be done using following steps:

Login → My Account → Privileges → MSME → Tick on MSME registered Enter Udyog Aadhaar memorandum number & Mobile no. Verify & Save

- 2.2 The bidders must fulfill the following minimum Qualifying Criteria:-
- 2.2.1 (A) The bidder should have successfully executed contract during last five (05) years ending last day of month previous to the one in which applications are invited for the similar work as given below:

One similar completed work costing not less than the amount equal to 80% of the Estimated Cost.

OR

Two similar completed works costing not less than the amount equal to 50% of the Estimated Cost.

OR

Three similar completed works costing not less than the amount equal to 40% of the Estimated Cost.



(The similar works above shall mean "Successfully executed the manufacturing/repair/ HP-HVOF coating of runner of Francis turbine".

Note: Copy of Letter of award(s) along with completion certificate(s) issued by Employers would be required to substantiate the experience in all cases. In case of client (issuing experience certificate) being non-government entity, the Contractor shall enclose TDS Certificate for the work for which experience has been claimed by the Contractor.

- (C) Average Annual Turnover during last 3 years, ending 31st March 2023 should not be less than the 30% of the estimated cost. The bidder shall submit Certificate from Chartered Accountant in respect of Annual Turnover during last 3 years, ending 31st March 2023 along with ITR to prove financial standing of the bidder. UDIN must be mentioned on the financial documents issued by CA.
- (D) Copies of original documents defining the constitution or legal status, place of registration, and principal place of business; written power of attorney of the signatory of the Bid to commit the Bidder.
- (E) The bidder has to submit signed QAP (As per Attached format at Annexure-A of SCC) before execution of work, which need to be approved by NHPC.
- (F) The Contractor has to mention in their technical bid about the machines installed at their workshops, balancing equipments (with detailed specification).

(G) Technical Qualifying Criteria

- (i) The repair of Runner involves Welding, Grinding, Machining, Stress relieving, Static / dynamic balancing of runner, run out checks, dimensional checks, Profile matching with template etc. The rated output of Runner of Uri-II PS is 61.22 MW and the approximate dimension of the runner outlet diameter with labyrinth is 2770 mm and approximate weight is 11.5 ton including labyrinth.
- (ii) The vendor/sub vendor should have successfully executed the repair work involving welding, grinding or machining etc. of Francis turbine of 40 MW and above and should have adequate machining and handling facility including stress relieving and static / dynamic balancing etc. for repair of runner of dimensions of Uri-II Power Station. In case any required facility for repair of the runner is not available, the vendor is required to produce the certificate/tie-up agreement with any good workshop with its credentials and experience.
- (iii) The credentials of the sub vendor / workshop shall be verified to the extent of technical capabilities only for successful execution of repair works of 40 MW and above Francis turbine and satisfactory completion thereof.
- (iv) In case the bidder has experience only in repair/refurbishment/manufacturing work, the firm/bidder is required to submit tie-up agreement with the sub-vendors having for HP-HVOF coating facility.



- (v) Firm/Sub-Vendor should have experience of HP-HVOF coating on underwater parts such as runner, guide vanes, labyrinths etc.
- (vi) The Firm/sub-vendor should have JP-5000 HP-HVOF system or higher having particle velocity for coating 700m/s or higher. The technical details of JP-5000 HP-HVOF system having particle velocity 700 m/s or higher shall submitted at the time of technical bid.
- (vii) The credentials of the sub vendor for HP-HVOF shall be verified to the extent of technical capabilities only for successful execution of HP-HVOF coating of 40 MW and above Francis runner and satisfactory completion thereof.
- (viii) In case the previous orders submitted by bidder are for combined nature wherein the HP-HVOF coating work or repair/refurbishment/manufacturing work has been carried out by a bidder, they will be compared against the composite estimated cost of the work. The experience of the bidder shall only be considered in monetary terms for evaluation purposes.
- 2.2.2 All Startups (whether MSEs or otherwise), falling within the definition as per Gazette notification- G.S.R. 501(E) dt. 23.05.2017 or as amended from time to time are exempted from meeting the qualification criteria in respect of Prior Experience-Prior Turnover subject to their meeting the quality and technical specifications for which necessary documents shall be submitted by such bidders. However, the Employer reserves the right to deny such exemptions to Startups (whether MSEs or otherwise) in case of circumstances like procurement of items related to public safety, health, critical security operations and equipments etc. Declaration in this regard is to be submitted by the Bidder as per Annexure-VIII.
- 2.2.3 All Micro and Small Enterprises (MSEs) are exempted from meeting the qualification criteria in respect of Prior Experience-Prior Turnover in public procurement subject to meeting of quality and technical specifications for which necessary documents shall be submitted by such bidders.
- 2.2.4 The reference date for considering the period for eligibility / qualification requirements above shall be the last day of the month previous to the one in which tenders are invited.
- 2.2.5 Each bidder must also produce with their Bid PAN, Goods & Services Tax Identification No. (GSTIN), EPF Registration No. and ESIC Registration No.
- 2.3 The Bidder should not have been banned / de-listed / black listed / debarred from business or declared ineligible on the grounds mentioned in para 6 of Guidelines on Banning of Business Dealings (Annexure-A) to Integrity Pact [if applicable], ITB Clause 9.0. Self-declaration in this regard is to be submitted as per enclosed Annexure-III.
- 2.4 Integrity Pact: Not Applicable



- 2.5 The Bidder, against whom proceedings for insolvency under the Insolvency and Bankruptcy code 2016, or as amended from time to time, have started, shall not be eligible for bidding. Self-declaration in this regard is to be submitted as per enclosed Proforma (Annexure-X of Section-I).
- 2.6 Bids of only those Bidders who are meeting the Eligibility Criteria specified above will be considered for evaluation and award of the Contract. Bidders will submit duly attested requisite supporting documents and testimonials with their Bids to prove their credentials and claim of meeting the Eligibility Criteria.
- 3.0 NHPC reserves the right to reject any or all tenders and shall not be bound to assign any reason for such rejection.
