### **(Domestic Open Competitive Bidding)**

Online electronic bids (e-tenders) are invited on behalf of NHPC Limited (A Public Sector Enterprise of the Government of India) from domestic bidders registered in India for entering into rate contract for the supply of Medicines to Teesta -V Power Station located at Balutar, PO-Singtam, East Sikkim for a period of two years. The estimated cost of medicines to be supplied is approximately **50 Lakh** per year which may vary as per requirement.

## 2.0 Eligibility Criteria for Bidders:

- 2.1 Bids of those Bidders who have not submitted the requisite Cost of bidding document and EMD (as per Instructions to Bidders (ITB) Clause 3.0 & 4.0) shall not be considered for evaluation, except in case of exemption as per Clause No. 3.2 & Clause No. 4.1 of ITB. **Further, those Bidders who fail to declare Udyog Aadhaar Memorandum (UAM) number on Central Public Procurement Portal (CPPP) shall not be able to avail the benefits available to MSEs as contained in Public Procurement Policy for MSE Order 2012 issued by Micro Small & Medium Enterprises, for tenders invited electronically through CPP. Such bidders shall be treated as non-MSE bidders and bids of such Bidders shall be considered only if it is accompanied by Cost of bidding document / EMD.**
- 2.2 The bidders must fulfill the following minimum Qualifying Criteria:-
- 2.2.1 Supplier/ Bidder should be Manufacturer/ Authorised Wholesaler /Authorized dealer/Authorized distributors of respective Medicine/ Medicine Company.

- 2.2.2 In case of Authorised Wholesaler/ Authorised Distributor/ Authorised Dealer, they have to submit a copy of valid authorisation letter from the manufacturer for the offered medicines. The authorisation letter should be valid for the period of ARC.
- 2.2.3 The Supplier/ Bidder must have valid Drug License under the prevailing Acts & Rules of Central/ State Government. The copy of same is required to be submitted along with the offer.
- 2.3 The Bidder should not have been banned / de-listed / black listed / debarred from business or declared ineligible on the grounds mentioned in para 6 of Guidelines on Banning of Business Dealings (Annexure-A) to Integrity Pact, ITB Clause 8.0. Self-declaration in this regard is to be submitted as per enclosed Annexure-III.
- 2.4 To improve transparency and fairness in tendering process and/or during execution of work undertaken, the Purchaser is implementing Integrity Pact as per Clause No. 8.0 of the ITB. The bidder must submit the Integrity Pact as per Proforma (Annexure-II) duly signed as per Clause 8.0 of ITB.

Pre-contract Integrity Pact is to be executed on plain paper with NHPC Ltd. at the time of submission of Bids. The successful bidder (Contractor) shall submit duly executed Integrity Pact on Non-Judicial Stamp Paper of appropriate value prior to issue of Supply Order.

- 2.5 Bids of only those Bidders who are meeting the Eligibility Criteria specified above will be considered for evaluation and award of the contract. Bidders will submit duly notarized requisite supporting documents *as asked* for against Cl. No. 2.2 of NIT and testimonials with their Bids to prove their credentials and claim of meeting the Eligibility Criteria.
- 3.0 The details/ information regarding online tendering i.e. Registration on CPP portal, Preparation of Bid and Submission of bid are available in the tender document and as well as on CPP Portal under “Bidders Manual Kit”.
- 4.0 NHPC reserves the right to reject any or all tenders and shall not be bound to assign any reason for such rejection.

**Note: The benefits of MSEs shall be available only for the goods produced and services rendered by MSEs for which they are registered.**

**The public procurement policy is meant for the goods produced by MSE and the traders are excluded from the purview of public procurement policy. Hence, if bidder is a trader, they should submit requisite Cost of bidding document and EMD (as per Instructions to Bidders (ITB) Clause 3.0 & 4.0) and are not eligible to avail exemption as per Clause No. 3.2 & Clause No. 4.1 of ITB.**
