- 1. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM_No.1_4_2021_PPD_dated_18.05.2023 OM_No.1_4_2021_PPD_dated_18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

 2. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE
- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. The bidders must fulfil the following minimum Qualifying Criteria:

All bidders shall include the following information and documents with their bids in, qualification Inform ation unless otherwise stated:

- (a) Copies of original documents defining the constitution or legal status, Memorandum of Understandi ng & Articles of Association, place of registration and principal place of business; written Power of Att orney along with a copy of board resolution. In case of General Power of Attorney, a true copy of the POA shall be notarised/ self-attested and in case of a specific Power of Attorney, the original POA.
- (b) Work experience supported by satisfactory performance/completion certificate to demo nstrate meeting the criteria stipulated below as Clause d(i). The work experience shown shall be supported with performance/completion certificate(s) from the Engineer-in-charge/Project H ead of the concerned work. In case the contractor produces the experience of a private work, the TD S certificate shall be submitted to establish that the particular work of particular value has actually been done by the contractor.
- (c) Information on financial criteria i.e. The average annual financial turnover during the last three ye ars ending 31st March of the previous financial year to the year of NIT should be at least ₹ 1,35,93 6.00, 30% of estimated cost (Last three years are FY 2021-22, FY 2022-23 & FY 2023-24). Copy of Certificate of CA mentioning Financial Turnover along-with Balance Sheet & Profit and L oss statement of last 03 (three) years is required to submit for ascertaining the bidder's me eting the financial criteria. The CA Certificate should have the Unique Document Identificat ion Number (UDIN) as per Gazette Notification No. 1-CA(7)/192/2019 dated 02.08.2019.
- (d) To qualify for award of the Contract, bidder should have:
- (i) Satisfactorily completed as prime contractor at least one similar work equal in value to 80% of estimated cost (₹ 3,62,496.00) or two works equal in value to 50% of estimated cost (₹ 2,26,560.00) or three works equal in value to 40% of estimated cost (₹ 1,81,248.00) in last seven (07) years.
- (ii) a) The manufactures/OEM (M/s Chhabi Electrical Private Limited) of the equipment/system can participate in the tender.

Or

The Authorized service provider/Channel Partner/distributor of the manufacture/OEM (M/s Chhabi Electrical Private Limited) of the equipment/system can participate on behalf of their manufacture/OEM.

b) If the Bidder is Authorized dealer, In that case bidder has to submit relevant authorization certificate issued by the Manufacturer/OEM as per details below:

"Only agencies submitting a general dealership or authorized certificate issued by manufacturer wit hout reference to any specific tender and having validity of such authorization for considerable dura tion shall be eligible for the particular tender.

Similar nature of work means: AMC of 220Volt DC Battery Chargers having capacity more than 220 Volt DC. 1200AH.

- 2. The previous financial year means the Financial Year previous to the year of issue of NIT.
- 3. The reference date for considering the period for eligibility/ qualification requirements above shall be the elast day of the month previous to the one in which tenders are invited.
- 4. Each bidder must also produce with their Bid :-
 - PAN;
 - · Goods & Services Tax Identification No. (GSTIN);
 - EPF Registration No.;
 - ESIC Registration No.;
 - Bank Account details;
 - · Annexure-I, II, III, IV, V and VI on their letter head;
 - · Acceptance of Scope of work;
 - Acceptance of Special Conditions of Contract (SCC);

Note: In case the bidder does not cover under ESIC including the present contract as per the ESI Act then he should submit an undertaking in this regard. Further, in case the bidder is covered under ESI but not ha ving the ESIC then he may submit the undertaking that in case the bidder is found as L-1, then such L-1 bid der will submit the required ESIC document before issuing of Letter of Intent/ Letter of Award.

5. Bids of only those Bidders who are meeting the Eligibility Criteria specified above will be considered for evaluation and award of the Contract. Bidders will submit duly notarised/ self-attested requisite supporting

documents i.e. documents defining the constitution or legal status, place of registration and principal place of business, written Power of Attorney along with a copy of board resolution and testimonials with their Bid s to prove their credentials and claim of meeting the Eligibility Criteria. All uploaded documents of bid shall be signed along with seal of the authorized person of the company.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्तें</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
