- 1. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. 1- The Bidder should be an OEM for CCTV Cameras.

The Bidder should be an Authorised Distributor/Dealer/SI/Partner bidder of OEM to quote on behalf of their Manufacturer, in case manufacturer does not quote directly. In such a case, the authorized dealer shall have to submit relevant 'General Dealership/ Authorisation Certificate' issued by the manufacturer, without reference to any specific tender having validity period.

(Supporting Documents in regard of SI or Partner Bidder shall submit supporting documents. Documents should be issued before the date of tender published.)

- 2- A valid ISO certification of manufacturer for manufacturing the s pecified equipment/system should be submitted with the bid.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
