1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. QUALIFYING CRITERIA

1. The Bidder shall furnish Earnest Money Deposit (EMD), for amount specifie d in the Bid Document only in the form of Demand draft/Banker's Cheque/B G/ Payment online through RTGS/NEFT/ internet banking in Beneficiary nam e: NHPC Ltd payable at SBI Uri Branch (Branch Code-02500, IFSC Code - SBI N0002500---NHPC A/C No. 31150155087). No exemption for submission of E MD shall be given to Authorized Dealers/ Distributors/ Service providers/Trad ers etc. Only valid MSE registered seller/ StartUp companies are exempted fr om submission of EMD.

The bidders must fulfil the following minimum Qualifying Criteria:-

2. The bidder should be Manufacturer of the equipment Portable gasoline e ngine driven hydraulic power pack.

- 4. The Bidder should have supplied at least two similar equipment/systems of same capacity or higher in previous seven years. 6. Financial Criteria:

a. <u>Turnover:</u>

The average annual financial turnover of 'The bidder' during the last thre e years, ending on 31^{st} March 2023 should be at least 50% of the estimat ed cost (or equivalent in foreign currency at exchange rate prevalent on 3 1 March of the respective accounting year) as per the Annual Report (Audi ted Balance Sheet and Profit & Loss Account) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India or equ ivalent in relevant countries.

b. <u>Working capital:</u>

1.0 Scope of Work:

The scope of this contract covers "Supply, Installation, testing & Commissio ning of Portable gasoline engine driven hydraulic power pack for Radial Gate s" for Uri-II Power Station as per 'Schedule of Quantities & Prices' and per at tached 'Technical Specifications'. The Contractor shall obey all the labor law s & statutory provisions during execution of work at their firm premises/at w ork place.

2.0 Prices and Taxes & Duties:

(i) Prices shall be Firm and on F.O.R destination basis i.e. at "Central Store, Uri-II Power Station, Uri, Baramulla, J&K" (This is most essential), inclusive of charges for packing, handling, forwarding, transportation, Installation and all applicable taxes & duties, including those assessed on the Employer. Furt her, the contract unit rates shall also be after taking into account the input t ax credit and other benefits.

(ii) Taxes, duties and levies, as applicable twenty eight (28) days prior to de adline for submission of bids (including on transportation), shall be mentione d in Price Bid i.e. Schedule of Quantities & Prices.

(iii) All taxes & duties mentioned in the Price Bid as per the above shall be p aid/ reimbursed against proper invoice as per rules and other relevant docu ment, if any and restricted to the total amount of Taxes & Duties in Price Bid subject to clause mentioned below. i. 70% amount for supplied items shall be released along with GST after deli very of material at Uri-II Power Station along with submission of relevant doc uments after successful inspection of equipment & materials within specifie d period.

ii. 30% amount of supplied items and 100% amount of installation charges s hall be released after successful testing & commissioning and 15 days unint errupted trial run of the system within specified period.

The following documents shall be presented by the firm for payment:

- Guarantee / warrantee certificate.
- · Inspection report and / or dispatch clearance.

4.0 Completion period:

The total completion period shall be 04 (four) months from the date of issue of Supply Order, which includes supply, installation, testing, commissioning and trial run.

5.0 Liquidated Damages:

For supply: If the Contractor fails to attain completion of scope of work or an y part thereof within the prescribed time for completion under clause 5.0 or any extension thereof, the contractor shall pay to the liquidated damages eq ual to the amount computed @ $\frac{1}{2}$ (half) percent per week or part thereof of Contract Price plus applicable GST. The aggregate amount of such Liquidate d damages shall in no case exceed 10% of the Contract Price. However cost compensation for any time extension shall not be paid.

6.0 Warranty Period:

The equipment/ items shall be warranted against poor quality or workmansh ip of material or manufacturing defects for a minimum period of 18 months f rom the date of supply or 12 months from the date of commissioning or stan dard warranty of the product offered by the Supplier/Original Equipment Ma nufacturer (OEM), if higher. During the Warrantee period the Supplier shall r epair/replace the defected items free of cost and no conveyance or any othe r charges shall be paid. If any defect is not remedied within a reasonable ti me, the Purchaser may proceed to do the work at the Supplier's risk and expense, but without prejudice to other rights, which the Purchaser may hav e against the Supplier in respect of such defects.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.

14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
