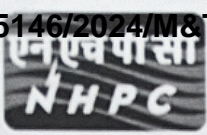
Terms and conditions:

- The auction of these scrap items shall be done on "As is where is" basis.
- The Reserve price of the equipment is ₹ 79040/- (Excluding GST 18%)
- The interested firms/parties/individuals may be allowed to take part in the auction on depositing Rs.10,000/-(Rupees ten thousand only) through Account Payee Demand Draft in favour of NHPC Ltd. Payable at SBI Roing **Account number 11362151275**. The above Amount is adjustable in case of successful bidders. However, it will be refunded to all the unsuccessful bidders. Govt. Depts. /PSUs. shall be exempted for depositing above amount for taking part in the auction.

However, purchaser will be informed that in case of such retention, the corporation will not be liable for deterioration of the condition of equipment/materials.
