1. Following Experience and Past Performance Criteria provided in the ATC shall supersede the GeM GTC provided above, for evaluation purpose.

**Experience Criteria:** The Bidder should have regularly Service, same or similar Category to any Ce ntral / State Govt Organization / PSU / Public Listed Company in at least one of the last three years. Copies of relevant contracts to be submitted along with bid in support of having Service in the releva nt year.

The reference date for considering the period for Experience Criteria requirement as above shall be t he last day of the month previous to one in which the bids are invited.

In case, Bidder have Service same or similar Category to non-Government entity, the bidder shall re quire to submit relevant contracts / experience certificate issued by the non-Government entity alon g with and notarized copy of Taxable invoice/ TDS certificate (if applicable) for corresponding value o f contracts issued by the non-Government entity.

**Past Performance**: The Bidder should have completed same or similar Category Service at least o ne of the last three years to any Central / State Govt. Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one year) to be sub mitted along with bid in support of quantity supplied in the relevant year.

The reference date for considering the period for Experience Criteria and Past Performance requirem ent as above shall be the last day of the month previous to one in which the bids are invited.

In case, Bidder has completed same or similar Category Service to non-Government entity, the bidde r shall require to submit relevant contracts / experience certificate issued by the non-Government e ntity along with and notarized copy of Taxable invoice/ TDS certificate (if applicable) for correspondin g value of contracts issued by the non-Government entity.

2. NHPC will not be responsible for any increase in tax rate and any new tax announced by the Govern ment in delayed period of the contract where default is on the part of the Contractor.

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
