Buyer Added text based ATC clauses

1.This service of hiring of Vehicle is reserved for identified Dibang Multipurpose Project PAF s (Project Affected Families) as per NHPC policy for Reservation of Works. The service will be awarded on Local Competitive Bidding basis. For this service, PAFs need to submit relevant documents as a proof of PAF (Project Affected Families) identity which shall be further duly verified.

2. For benefit of Larger population of nearby area of the Project, at a time not more than 4 (Four) works/services be allotted/awarded to the same entity. The bidder shall have to submit an undertaking in this regard in Annexure-A format. The value of works and services to be awarded to any single entity at any point of time shall be limited to 125 Lakhs (Rs. One hundred and twenty-five lakhs).

3. The eligibility of PAF to participate in the tenders shall be considered taking into account

the works awarded to PAF's family as a whole. The person, his family along with legal heirs shall be considered as single PAF. Declaration in this regard shall be provided by the PAF. In case of false declaration, the concerned PAF shall be debarred from participation of tender for six months.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
