- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. # **QUALIFYING CRITERIA**

1. The Bidder shall furnish Earnest Money Deposit (EMD), for amount specified in the Bid Document only in the form of Demand draft/Banker's Cheque/BG/Payment online through RTGS/NEFT/ internet banking in Beneficiary name: NHPC Ltd payable at SBI Uri Branch (Branch Code-02500, IFSC Code - SBINO 002500---NHPC A/C No. 31150155087). No exemption for submission of EMD shall be given to Authorized Dealers/ Distributors/ Service providers/Trade

rs etc. Only valid MSE registered seller/ StartUp companies are exempted from submission of EMD.

The bidders must fulfil the following minimum Qualifying Criteria:-

2. The bidder should be Manufacturer of the equipment Portable gasoline e ngine driven hydraulic power pack.

- **4.** In case a dealer is participating in a tender on behalf of one manufacturer, he is not allowed participating / quoting on behalf of another manufacturer in this tender or in a parallel tender for the same item. All such bids with same make/manufacturer will be rejected.
- 5. The Bidder should have supplied at least two similar equipment/systems of same capacity or higher in previous seven years. In support of the same, the bidder should submit authenticated copies of supply orders for similar it ems issued by various clients with Bill of Quantities and completion certificate for above supply during last seven years ending last day of month previous to the one in which applications are invited.

### a. <u>Turnover:</u>

The average annual financial turnover of 'The bidder' during the last thre e years, ending on 31<sup>st</sup> March 2024 should be at least 50% of the estimat ed cost (or equivalent in foreign currency at exchange rate prevalent on 3 1 March of the respective accounting year) as per the Annual Report (Audi ted Balance Sheet and Profit & Loss Account) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India or equivalent in relevant countries.

# b. Working capital:

# 1.0 Scope of Work:

The scope of this contract covers "Supply, Installation, testing & Commissio ning of Portable gasoline engine driven hydraulic power pack for Radial Gate s" for Uri-II Power Station as per 'Schedule of Quantities & Prices' and per at tached 'Technical Specifications'. The Contractor shall obey all the labor law s & statutory provisions during execution of work at their firm premises/at w ork place.

## 2.0 Prices and Taxes & Duties:

- (i) Prices shall be Firm and on F.O.R destination basis i.e. at "Central Store, Uri-II Power Station, Uri, Baramulla, J&K" (This is most essential), inclusive of charges for packing, handling, forwarding, transportation, Installation, AMC and all applicable taxes & duties, including those assessed on the Employer. Further, the contract unit rates shall also be after taking into account the input tax credit and other benefits.
- (ii) Taxes, duties and levies, as applicable twenty eight (28) days prior to de adline for submission of bids (including on transportation), shall be mentione d in Price Bid i.e. Schedule of Quantities & Prices.
- (iii) All taxes & duties mentioned in the Price Bid as per the above shall be p aid/ reimbursed against proper invoice as per rules and other relevant docu ment, if any and restricted to the total amount of Taxes & Duties in Price Bid subject to clause mentioned below. No other taxes and duties shall be payab

le / reimbursable by NHPC. TDS wherever statutorily required under any Tax Act/ Rule shall be deducted and deposited and necessary certificate will be p rovided by the Employer.

# 3.0 Terms of Payment:

- i. 70% amount for supplied items shall be released along with GST af ter delivery of material at Uri-II Power Station along with submission of relevant documents after successful inspection of equipment & materials within specified period.
- ii. 30% amount of supplied items and 100% amount of installation charges shall be released after successful testing & commissioning and 1 days uninterrupted trial run of the system within specified period.

The following documents shall be presented by the firm for payment:

- · Invoice in triplicate (One original and two copies).
- · Detailed packing list / challan.
- LR copy.
- · Guarantee / warrantee certificate.
- · Inspection report and / or dispatch clearance.
- · Calibration certificates of the Data logger and the sensors.
- General Authorization for Data Logger from OEM.
- Insurance declaration / document.

### In case of MSE:

All the payments for the supplies and/ or services rendered by MSEs (Micro & Small Enterprises) Supplier/ Contractor under the Contract shall be release

d within forty five (45) days from the day of acceptance\*. In case, payment are not released as mentioned above, NHPC shall pay the principal amount plus compound interest with monthly rests from the date of immediately foll owing the date agreed upon @ three times of bank rates as notified by Reserve Bank of India from time to time.

\* Day of Acceptance means - day of the actual delivery of goods or the rend ering of services; where any objection is made in writing by the buyer regar ding acceptance of goods or services within fifteen (15) days from the date of delivery of the goods or the rendering of services, the day on which such objection is removed by the Supplier.

# In case of non-MSE:

All the payments for the supplies and/or services rendered by non-MSEs (no n-Micro & Small Enterprises) Supplier/Contractor under the Contract shall be released within forty five (45) days from the receipt of invoice/ bills from the Contractor/ Supplier complete in all respect.

In case, payment are not released as mentioned above, NHPC shall pay the principal amount plus simple interest from the date immediately following the date agreed upon @ 6% (six percent) per annum.

### 4.0 Completion period:

The total completion period shall be 04 (four) months from the date of issue of Supply Order, which includes supply, installation, testing, commissioning and trial run.

### 5.0 Liquidated Damages:

For supply: If the Contractor fails to attain completion of scope of work or an y part thereof within the prescribed time for completion under clause 5.0 or any extension thereof, the contractor shall pay to the liquidated damages eq ual to the amount computed  $@ \frac{1}{2}$  (half) percent per week or part thereof of Contract Price plus applicable GST. The aggregate amount of such Liquidate d damages shall in no case exceed 10% of the Contract Price. However cost compensation for any time extension shall not be paid.

### **6.0 Warranty Period:**

The equipment/ items shall be warranted against poor quality or workmansh ip of material or manufacturing defects for a minimum period of 18 months f rom the date of supply or 12 months from the date of commissioning or standard warranty of the product offered by the Supplier/Original Equipment Ma

nufacturer (OEM), if higher. During the Warrantee period the Supplier shall r epair/replace the defected items free of cost and no conveyance or any othe r charges shall be paid. If any defect is not remedied within a reasonable ti me, the Purchaser may proceed to do the work at the Supplier's risk and expense, but without prejudice to other rights, which the Purchaser may hav e against the Supplier in respect of such defects.

### 7.0 Transit Insurance:

Transit Insurance of all material shall be in scope of the contractor.

# 8.0 Inspection of Material:

Inspection shall be carried out by Authorized representative of purchaser at Central Store, Uri-II Power Station, NHPC, Uri, Baramulla, J&K-193123 after receipt of material.

# 9.0 Engineer-In-Charge:
