If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. ELIGIBILITY CRITERIA:

This Bid is being floated on **PAC (Proprietary Article) Basis** and the bidder must fulfil the following minimum Qualifying Criteria:-

1. The bidder should be manufacturer i.e. "M/s. Yuken India Limited".

OR

Authorized dealer of a manufacturer of the equipment/system to quote on behalf of their manufacturer in case manufacturer does not quote directly. In such a case, the authorized dealer shall have to submit a general dealership or authorized certificate issued by manufacturer without reference to any specific tender and having validity of such authorization for considerable duration shall be eligible for the particular tender.

2. A certificate indicating that the rates quoted are not higher than those charged to other Govt./PSU's for similar supplies made in recent past should accompany the bid in support of its price reasonability.
3. Firm shall provide 'Interchangeability Certificate' to confirm that materials to be supplied shall be interchangeable with the originally items i.e. Yuken solenoid directional valve & logic cartridge.
4. Bidder should submit acceptance of Technical Specifications.
5. Bidder should submit acceptance of Special Conditions of Contract (SCC).

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्यवाई का आधार होगा।
