- 1.1. Online electronic bid (e-tender) at GeM portal is invited through domestic competitive bidding u nder "Two Packet Bid system" for and on behalf of NHPC Limited (A Public Sector Enterprise of t he Government of India) from eligible sole bidder for the work of "AMC of Rope Drum Hoists, Gantry Crane & EOT crane of different HM Components installed at Parbati-III Power Station".
- 1.2. (A) Instant bid type is "Two Packet Bid", so bidder/seller is advised to upload/quote financial offer in its financial bid only as where applicable at GeM Portal.
 - (B) Utmost care shall be taken by bidder/seller while uploading technical bid documents at GeM Port all that it should not contain "Financial offer/Price bid" in any form. The bidder/seller are caution ed that uploading financial offer or disclosing/revealing its quoted price in any form in its technical bid document will result in rejection of tender.
- 1.3. Bids of those Bidders who have not submitted the EMD as sought under "EMD Details of Bid Doc ument" shall not be considered for evaluation, except in case of exemption. The bidder seeking

EMD exemption, must submit the valid supporting document for the relevant category as per G eM GTC with the bid. Under MSE category, only Service Providers for Services are eligible for ex emption from EMD. Traders are excluded from the purview of this Policy.

1.4. Qualification Criteria

- ii.) The Bidder must have successfully executed /completed at least one single order of 80 % of the Annualized Estimated Cost or 2 orders each of 50 % of the Annualize d Estimated Cost or 3 orders each of 40 % of the Annualized Estimated Cost for similar ser vice(s) in last Seven (07) years.

- iv.) In case of experience certificates produced by the bidders for having execute d works/service for Private Organizations, TDS Certificates/Annual Information Statement (AIS)/Form 26AS shall also be produced along with experience certificates. The reference date for considering the period of preceding Seven (07) Years for general & specific techn ical experience shall be the last day of the month previous to the one in which Tenders ar e invited.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
