- 1.1. Online electronic bid (e-tender) at GeM portal is invited through domestic competitive bidding under "Two Packet Bid system" for and on behalf of NHPC Limited (A Public Sector Enterprise of the Government of India) from eligible sole bidder for the work of **"Testing of Stack Emission / Noise of DG Sets, Ambient Air, Drinking Water and Inlet/Outlet Samples of STP for two years at Parbati-III Power Station"**.
- 1.2. (A) Instant bid type is "Two Packet Bid", so bidder/seller is advised to upload/quote financial offer in its financial bid only as where applicable at GeM Portal.
- (B) Utmost care shall be taken by bidder/seller while uploading technical bid documents at GeM Portal that it should not contain "Financial offer/Price bid" in any form. The bidder/seller are cautioned that uploading financial offer or disclosing/revealing its quoted price in any form in its technical bid documents is strictly prohibited.

1.3. **Eligibility Criteria**

i.) Bidder must have valid certificate of Accreditation for Standard ISO/IEC 17025:2017 issued by NABL in the field of "TESTING" having scope of "Environmental Tests".

ii.) All bidders meeting Qualification criteria as defined in clause 1.4.

1.4. **Qualification Criteria**

i.) Minimum average annual financial turnover during the last three (03) financial years ending 31st March of previous financial year should be equal to the amount indicated under Bid details.

ii.) The Bidder must have successfully executed /completed at least one single order of 80 % of the Annualized Estimated Cost or 2 orders each of 50 % of the Annualized Estimated Cost or 3 orders each of 40 % of the Annualized Estimated Cost for similar service(s) in last Seven (07) years.

· (Similar Service is defined as "**Lab Testing of Environment samples**").

· (Annualized Estimated Cost= Total Estimated Cost/ Period of Completion in years (n))

iii.) 1.5. If the bidder is a Startup/Micro or Small Enterprise as per latest definition under MSME rules, the bidder shall be exempted from the requirement of "Prior experience -Prior Turnover" subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from "Prior experience -Prior Turnover" the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
