- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 2. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

SPECIAL CONDITIONS OF CONTRACT

1. INSTALLATION & COMMISSIONING:-

1) All tools, tackles, testing instruments etc. as required during execution of work shall be arranged by bidde r. The bidder has to ensure timely installation, testing and commissioning as per the terms of contract. Tra nsportation of materials required for the work/manpower shall be arranged by the bidder at their own cost

- 2) The installation of equipment shall be accepted only after installation tests / inspection from Engineer In c harge or its authorized representative.
- 3) The bidder should ensure while installation of LAN, day-to-day functioning of official work and existing net work setup/connectivity/internet connectivity should not get disrupted.
- 4) In case, the quantity of laying cables or fixing wall mount sockets etc. exceeds or is less than the quantity in bid price schedule, the payment for the executed quantity shall be paid on pro-rata basis, for the actual quantities consumed / for which the installation is carried out through the Bidder on Certification by Engine er-in-charge or its representative.
- 5) Any other work required for making the network functional up to the satisfaction of Uri-ii Power station is a lso in the scope of Bidder.
- 2. **SITE SURVEY:** The Bidder at the Bidder's own responsibility, cost & risk is encouraged to visit and exami ne the site of works and its surroundings and obtain all information that may be necessary for preparing the Bid and make a detail survey before submitting the bid. The network design and system implementation should also concentrate on flexibility of future expansion and maintainability without much hassle. The costs of visiting the Site shall be at the Bidder's own expense.
- **3. NETWORK INTEGRATION : -** It shall be the responsibility of the vendor to integrate the newly installed L AN to the existing network wherever required.

4. Make Of Equipment :-

- 1) All Switch should be from the reputed and same make.
- 2) All Passive items should be reputed make.
- 3) 27U, 15U Rack and 9U Rack should be from the reputed and same make.
- 4) Data Sheets of each active item in respect of which rates are quoted should also be attached.
- **5. PACKING :-** All equipment and materials supplied against this contract is in the scope of Bidder. The bidd er shall be responsible for any loss or damage during transportation, handling and storage due to improper packing.
- **6. Transportation & Insurance :-** All transportation, transit insurance required for supply and commissioni ng of the Network system are to be arranged by the bidder and no extra cost shall be paid. Any damage to the material and system supplied through this contract till the handover of the system shall be the respon sibility of the vendor and insurance (if any) required to mitigate the risk shall be borne by the vendor.
- **7. Splitting of Contract: -** This is a consolidated contract covering all aspects i.e, Supply , Installation, Com missioning with OEM warranty period , it will be considered as a single unit and there will be no splitting of the contract .

9. SCOPE OF WORK DURING INSTALLATION AND WARRANTY:

Maintenance during warranty period: The bidder is responsible for providing proper maintena nce of the LAN network; repair/replacement of each and every item damaged/ malfunctioned due t o technical glitch, lightning/thundering etc. during the OEM warranty from the date of successful co mmissioning without any extra cost. An undertaking (sealed and signed by bidder and duly notariz ed on bidder's letter head) for the same is to be uploaded by the bidder at the time of bidding.

The Bidder shall be responsible for providing all materials, equipment, and services, specified or ot herwise, which are required to fulfill the intent of ensuring operability, maintainability, and reliability of the complete equipment covered under this scope of work. This work shall be in compliance with all applicable standards, statutory regulations and safety requirements in force from date of aw ard of this contract.

The bidder shall also be responsible for deputing trained/experienced personnel for installation, tes ting, commissioning and other services under the scope of work as per specification. All required t ools and tackles for completing the work as per the specification is also the responsibility of the bid der.

- **10. RELIABILITY:-**The equipment offered must be highly reliable and field proven. The equipment supplied s hould operate without any deviation in quality or degradation of system performance and all the paramete rs mentioned should be guaranteed over as mentioned in the required technical specifications in the Buyer Specification Document.
- 11. SAFETY: Bidder has to adopt proper safety aspect as per NHPC & other industrial norms and ensure saf ety of their personnel and others during laying of OFC cable, erection, installation, commissioning and mai ntenance of the system. The successful bidder shall be responsible for safety & security of the men & mate rials engaged in this work & all types of necessary safety precautions should be followed during execution of the work. The successful bidder will also have to arrange for all materials, safety tools, like helmet, shoe s, safety belt etc. In no matter NHPC shall be liable to the successful bidder or any member of the contract or's staff or any other person deputed by the successful bidder in case of injuries or death caused as a res ult of accidents either within or outside the working areas of Power Station Area.
- **12. DOCUMENTATION OF THE LAN:** Configuration details of switches, network schematic drawings, OFC la yout drawings, drawings of the UTP cabling with numbers at I/O end and jack panel end, location of jack panels, I/O location, location of the switches, ferrule details, cable routing to be furnished in form of a docum ented hard copy/handbook along with the acceptance shall have to be submitted to the Engineer-In-charg e.
- **13. TAKING OVER: -** The system shall be taken over by Engineer-In-Charge or authorized representative afte r successful completion and acceptance. The warranty of the material/ equipment shall start with effect from the date of hand over of the network.
- **14. WARRANTY:** Onsite warranty for all Hardware delivered and installed for minimum one year and extende d as per OEM Guarantee/ Warrantee period from the date of successful installation and acceptance. In cas e, a part thereof or the whole equipment is found defective the same will have to be rectified/replaced on f ree of charge basis without lapse of time. In case the equipment are not repaired/replaced within the "Serv ice" Time quoted the Bank Guarantee will be invoked without assigning any reason.
- **15. Others:** The Switch OEM must submit declaration regarding their own manufacturing setups and shall n ot have 3rd party manufacturing from any company blacklisted in India or any company sharing land bord er with India.

The quoted product, which the bidder is mentioning as complied in the above specifications, must be available in their respective OEM website and datasheet both for the verification purpose. In case of any discrepancy found, the bid may be summarily rejected. A compliance sheet against each specification of all items is required to be submitted by the bidder.

The Bidder should not bid / supply any equipment / item that is likely to be declared end- of-sale a nd all patches and updates of firmware would be available for next 05 years as and when released by OEMs without any additional cost (Declaration from vendor is required).
